### **Notification of transactions of directors/persons discharging managerial responsibilities and connected persons**

Hrvatski Telekom d.d. (“HT d.d.” or “the Company”) hereby notifies that on 11 April 2014 the Raiffeisen Mandatory Pension Fund Management Company d.d. informed the Company of dealings in HT d.d. shares. This notification is made because Mr. Damir Grbavac, an insider on the General Insider List of the Company and a Member of the Supervisory Board of HT d.d., also holds the position of President of the Management Board of the Raiffeisen Mandatory Pension Fund Management Company d.d., which is thereby considered a connected person.

The above stated connected person made the following transactions regarding HT d.d. shares in the name and on behalf of the Raiffeisen Mandatory Pension Fund:

- On 7 April 2014, 4,000 ordinary shares were acquired at an average price of HRK 165.278153 per ordinary share, representing 0.0049% of the Company’s issued share capital.
- On 9 April 2014, 5,000 ordinary shares were acquired at an average price of HRK 166.029598 per ordinary share, representing 0.0061% of the Company’s issued share capital.
- On 10 April 2014, 3,954 ordinary shares were acquired at an average price of HRK 166.105673 per ordinary share, representing 0.0048% of the Company’s issued share capital.
- On 11 April 2014, 2,046 ordinary shares were acquired at an average price of HRK 165.519785 per ordinary share, representing 0.0025% of the Company’s issued share capital.

Following these acquisitions, the Raiffeisen Mandatory Pension Fund holds 6,541,856 ordinary shares in the Company, representing 7.9887% of the Company’s issued share capital and the same number of votes at the General Assembly of the Company.
